



14th (2021) TOYOTA Dream Car Art Contest Entry Terms and Conditions:

ELIGIBILITY REQUIREMENTS

- No product purchase or participation/entry fee is necessary.
- Entries must be the original artwork of a child applicant (hereafter referred to as Applicant) in accordance with the following conditions: (a) the age of the Applicant must fall within the category indicated on the entry form and (b) the Applicant must be a legal resident of Sultanate of Oman at the time of entry.
- Previously published artworks, artworks that have been entered in any other contest and artworks that infringe any third party rights may not be submitted. To be eligible, artworks must be related to the theme of the contest in which they are submitted.
- A winner and his/her parent(s) or legal guardian will be required to certify that the Applicant's submission has not been published previously, has not been entered in any other contest and does not infringe any third party rights.
- An applicant may enter as many times as he or she wishes, however, each entry must be mailed in a separate envelope to Saud Bahwan Automotive LLC, P.O Box 3168, Ruwi, Postal Code 112, Sultanate of Oman, hereafter referred to as SBA or be submitted directly to any Toyota showroom. Prizes will be limited to one per Applicant.
- Entries must be submitted on paper measuring within 400 mm to 550 mm (15.7 to 21.7 inches) or smaller. This corresponds to either A3 size or tabloid size. Entries must be hand-drawn, colored illustrations with a background and must not be created digitally. Any type of paper is permissible, and any artistic medium (any paint including water paint, color markers, crayons, etc.) may be used to create an entry. Any artwork with thickness over 5mm will be disqualified. Collaborative artwork drawn by multiple individuals and artwork created by a person other than the participant will not be accepted.
- Each submission must be accompanied by an entry form containing the necessary information. Entry forms are available at Toyota showrooms or can be downloaded from the Toyota Oman website (www.toyotaoman.com). The questionnaire printed on the backside of drawing sheet must be duly filled before submission of the entry.
- The required information to be filled in the entry form is outlined below. The agreement clause (13) must include the signature of the Applicant and his/her parent(s) or legal guardian.
 1. Age category, 2. Title of the artwork, 3. Concept of Dream Car the Applicant drew
 4. Name of the Applicant, 5. Age and date of birth of the Applicant, 6. Gender of the Applicant, 7. Name of parent(s) or legal guardian of the Applicant, 8. Postal address
 9. Telephone number, 10. Email address (if available), 11. Signature of the Applicant and his/her parent(s) or legal guardian to indicate their agreement
- Where both parents are able to exercise parental rights, both parents should sign. If only one of the parents is able to exercise parental rights, the signature of one parent

will be accepted. In the case that neither parent is able to sign, the legal guardian should sign.

- By submitting an entry, the Applicant and his/her parent(s) or legal guardian agree to be bound by these terms and conditions and accept and shall not object or take actions against the final decision by juries whom Saud Bahwan Automotive LLC and TMC arranged.
- Children of employees of TMC, Saud Bahwan Automotive LLC and dealers are also eligible to participate.

DEADLINE FOR ENTRY

- Entries must be received by 1st Dec 2020 by one of the methods of submission indicated below.

HOW TO ENTER

- Entries can be submitted as follows:
 - (1) By mailing the entry to the following Administration Office of Toyota Dream Car Art Contest Saud Bahwan Automotive LLC, P.O Box 3168, Ruwi, Postal Code 112, Sultanate of Oman.
 - (2) By submitting the entry directly to Toyota showrooms across Oman.

JUDGING

- Only submissions that meet the above criteria will be eligible for judging in the National, Regional and World Contest.
- The top 3 places in each age category in the National Contest (in total 9 winners per National Contest (which includes 14th (2020) TDCAC & 14th (2021) TDCAC winners) will be submitted to the Regional & World Contest. Entries in the National, Regional and World Contest will be judged by juries and outside experts arranged by TMC and Saud Bahwan Automotive LLC from the viewpoint of originality and creativity principally.
- In the Regional & World Contest, award winners and finalists will be selected out of the entries submitted from the various participating countries. However, there will be no relationship between the ranking of winning entries in the National Contest and the ranking of winning entries in the Regional & World Contest. All decisions of the juries are final.

REGIONAL CONTEST

- An award certificate and prize money intended to be used for educational purposes will be presented to grand prize winners in each category (3 persons in total) as supplementary prize. (3,000 USD prize money to each winner)

WORLD CONTEST

- An award certificate and prize money intended to be used for educational purposes will be presented to grand prize winners in each category (3 persons in total) & special award winners in all categories (2 persons in total) and their schools as supplementary prize. (5,000 USD prize money to each winner, 10,000 USD prize money to each winner's school)

GUIDELINES FOR PRIZE MONEY

- All the taxes related to prize money and expenses which are not specifically described on this official terms and conditions should be paid and borne by the winner or his/her parent(s)/guardian and winner's school themselves.
- The prize money payment should be settled based on the rate of remittance date.
- When receiving prize money, the winner's parent(s)/guardian and responsible person of his/her school need to sign on the receipt.
- The necessity of filing final tax returns/tax payment should be confirmed by the winner or his/her parent(s)/guardian and winner's school themselves based on local regulations and proceeded accordingly.
- Regional & World Contest Winners and their schools should agree with the Terms and Conditions which will be separately set to receive prize money.

Regarding supplementary prize, please note that there is possibility to change depending on contest organizer's discretion.

ANNOUNCEMENT OF WINNERS

- Winners of the National Contest will be announced in February, 2021.
- Competition results are scheduled to be announced on website (www.toyotaoman.com). Winners of the National, Regional and the World Contest will be notified separately by Saud Bahwan Automotive LLC.
- TMC requires each winner and the winner's parent(s) or legal guardian to sign a declaration of eligibility/availability and a liability/publicity release for the benefit of the winner. If the declaration is not signed, the prize will be forfeited and awarded to the runner up.
- The beneficiary of the prize shall be the winner himself/herself, and not the parent(s) or legal guardian. The involvement of a winner's parent(s) or legal guardian in the contest, including, without limitation, the prize-winning process, does not constitute nor entitle the parent(s) or legal guardian to any rights or claim against Saud Bahwan Automotive LLC or TMC. In the event that notification of a prize or the prize itself is returned as undeliverable, the prize will be forfeited and awarded to the runner up.
